

Ordinances for Humane Society Members

Dog Restraint

Killeen

Sec.6-36. Restraint, Can not be tied outside without supervision. 526-4455

Harker Heights

Sec.90.49. Animal Restraint, Can only use tether with swivels, supervision not required. 953-5400

Copperas Cove

Sec.3-11. Tying, staking animals on street, sidewalk, crossing prohibited, Can only use tether with swivels. Supervision not required. Animal must have shelter and no-spill water and food bowls within reach. 547-5584

Selling of Animals

Killeen

Sec.6-38. Cruelty to animals, (d) No person shall give away any live animal, fish, reptile or bird as a prize for, or as an inducement to enter any contest, game or other competition, or as an inducement to enter a place of amusement: or offer such animal, fish, reptile or bird as an incentive to enter into any business agreement whereby the offer was for the purpose of attracting trade.

Sec.6-136. Premises; regulations, It shall be unlawful for any person to sell, trade, lease, rent or give away and live animal on any roadside, public right-of-way, commercial or private parking lot, or flea market within the city limits.

Sec.6-137. Kennel, pet store, riding school or stables, or other commercial activities, Only two litters per year. **Sec.6-138. Breeder license**, One permit per animal.

Harker Heights

Sec.90.09. Sale or adoption of Animals Restricted, It shall be unlawful for any person to sell, or offer for adoption, a live animal or fowl directly from public property or along a public right-a-way.

Copperas Cove

Sec.3-14. Selling animals, (a) It is unlawful for any person to sell, trade, barter, lease, rent, give away, or display for a commercial purpose any live animal on the roadside, public right-of-way, commercial parking lot, or any flea market.

(b) It shall be unlawful for a person to sell, deliver, trade, or barter a dog, cat, or rabbit less then six (6) weeks old.

Sec.6-38. Cruelty to animals, (j) Outside dogs must have doghouse.

Sec. 90.48. Keeping animals; other responsibilities, Outside dogs must have doghouse.

Copperas Cove

Sec. 3-10. Outdoor shelter for dogs, Outside dogs must have doghouse.

Sec.150.32 (C), All fences must be maintained in good order and repair. 953-6548, 286-1837

International Property Maintenance Code Sec. 302.7, All accessory structures, including detached garages, fences and walls, shall be maintained structurally sound and in good repair. 547-4221
